It is the members responsibility to supply the required documentation to qualify for the rebate. Rebates are based on one rebate per account, but bundling of heating equipment with a water heater is allowed.

McLean Electric Water Heater Rebate Agreement

McLean Electric will offer the following rebates for a water heater that has a .94% or greater Energy Factor:

- a. 80-85 gallon - \$250
- b. 100-105 gallon - \$275

In order to receive the rebate the Member must agree to:

1. The Member agrees to MEC's Off-Peak Program which is to have a Load Control Receiver (LCR) installed by MEC. It is the Member's responsibility to schedule the LCR with MEC's electrician.
2. The Member will receive a \$7.00 bill credit every month if their main meter usage is at least 600 kWh.
3. The Member agrees to this program for a period of five (5) years. If the Member wishes to discontinue the program prior to five (5) years from the date signed up, they must reimburse MEC for all costs of the water heater rebate (prorated).

Indemnity & Hold Harmless Agreement

Member hereby agrees to indemnify and hold MEC harmless from any and all Claims, complaints, lawsuits, arbitration proceedings, administrative proceedings, warranty disputes and any other adversary matters relating in any way whatsoever to MEC's performance or non performance under or pursuant to this contract, or related to MEC's actions or inactions at the job site. This provision shall protect MEC from any and all personal injury, workman's compensation, wrongful death, unemployment, discrimination, breach of warranty, negligence, strict liability, breach of contract, and any other claim arising from the performance or nonperformance by MEC and/or any person of firm acting at MEC's behalf, including but not limited to MEC's employees.
