MESSAGE TO OUR MEMBERS



Larry Gessele President

Busy...Busy...Busy!!

It has been another busy year for McLean Electric Cooperative.

The year started off with another storm. This was a frost event due to the mild temperature we were experiencing. The damage was marginal, but again, any damage is not appreciated. The event was submitted to FEMA but was under the threshold for a disaster declaration, so we had to absorb the cost without assistance. Then, the year ended in December with a massive ice storm in the southeast/ south-central part of the state. We were fortunate not to be affected by this event and were able to assist other co-ops with mutual aid. This exemplifies one of our guiding principles, cooperation among cooperatives. That storm left thousands without power for days. Most people were happy with the mild winters, but it makes us nervous for obvious reasons.

Our priority is to deliver safe, reliable, affordable electric service to our members, with safety at the forefront. MEC was recognized with several awards for 2023. The first was a successful Rural Electric Safety Achievement Program (RESAP) award. Your co-op is reviewed for our policies and procedures which include onsite visits. Another was a Safety

Performance award for having zero OSHA reportable injuries for one year. Finally, we stood alone with the Safety Excellence award for five consecutive years with no lost time injuries. These awards are proof of the staff's dedication to safety.

Our board of directors, management, and staff are also dedicated to maintaining the reliability of our system while keeping costs as low as possible. Along with other rural electric cooperatives in the state, we have had to raise our monthly base rate to try to cover our fixed costs. Much of the increase is due to the 50 to 100% + increase in materials costs that we need to maintain and upgrade our system while trying to keep up with about 4% annual growth. This increased our cash flow due to carrying a large inventory, due to supply chain issues that still exist. We have inventory in the yard for the 2024 and 2025 projects, as lead times for delivery are 6 months to 2 years, depending on the material.

We also have a concern for community, which is another guiding principle. MEC Trust Board (Operation Round-up) consists of seven members appointed by the board of directors. These trustees review applications for grants with funds provided by you, the member. Operation Round Up provided \$11,900 in projects around the county.



In addition, MEC is always proud to sponsor events and projects for organizations in our service territory. Last year, we partnered with Basin Electric, CoBank, and RDFC, supporting local schools, cultural festivals, and community events. Our commitment to community is an integral part of who we are as a cooperative, and we will continue to prioritize and support community development efforts in the future.

Some other highlights for 2023 include expansion at Blue Flint Ethanol. Beginning in October 2023, BFE successfully implemented carbon capture, which will allow it to stay viable in the ethanol market with an industry-leading carbon score.

Another is the continuing growth in White Shield and MHA Nation. MHA Nation continues to invest in its communities for the sustainability of its members. We appreciate its innovation, which makes it a growing, stable community and business in McLean County and the State of North Dakota.

We would like to thank the board and employees for all the dedication and hard work they have done this past year.

We look forward to visiting with you at your annual meeting.

ANNUAL MEETING MINUTES – JUNE 20, 2023

The 78th Annual Meeting of the members of McLean Electric Cooperative, Inc., was held at the company's headquarters in Garrison, North Dakota, on the 201h day of June, 2023. The meeting was called to order by President Lany Gessele at 6:30 o'clock p.m.

Dinner was prepared by Border States Electric and served by the Board of Directors and staff, and the Garrison American Legion Team "The Titans".

Secretary Rod Stockdill informed President Gessele that a quorum was present and President Gessele informed the attendees that the Cooperative was open for business.

President Gessele introduced Pastor Rick Torkelson of Washburn Baptist Church, of Washburn, North Dakota, who gave the opening invocation.

President Gessele recognized present and past military service personnel and led the attendees in the Pledge of Allegiance followed by the playing of the National Anthem.

President Gessele introduced the dignitaries and guests who were in attendance and introduced Jessica Bell, Vice-President of Government and Public Affairs of Rainbow Energy Center to provide a key-note address. During her address she reported that Rainbow is celebrating the 1st anniversary of taking ownership of the Coal Creek Station and the Nexus DC line. She spoke about the projects involving Coal Creek Station, the Nexus line, Discovery Wind Project, and carbon capture and sequestration.

President Gessele reported that the notice of the 78th Annual Meeting and the minutes of

the 7T" Annual Meeting were ready to be read for approval. It was moved that a reading of the notice and minutes be waived and that they be approved as presented. The motion was seconded and carried.

President Gessele provided his President's report, as follows:

- He thanked those that helped put together this year's Annual Meeting.
- The Cooperative is experiencing high growth and has been very busy with three crews working.

- Meter change over is ongoing.
- The cooperative is as financially sound as ever.
- He recognized the cooperative staff and thanked them for their work and service to the cooperative.

President Gessele introduced General Manager/CEO, Mark Doyle, to provide his address to the attendees. Manager Doyle discussed the following:

2022 year review:

- The closing of the Coal Creek Station sale to Rainbow Energy.
- Ice storm experienced with many outages and downed poles.
- No lost time by any of the crews.
- Improving member communication. The continuation of the supply chain issues.
- The Cooperative is involved in community support including the provision of scholarships to local school districts in the cooperative's territory, Kid's programs and community donations and sponsorships totalling \$23,795.00
- 2022 was a financially strong year for the Cooperative. The Cooperative experienced a 5.4%plant growth and ended 2022 with an equity ratio of 36.1 %. 2022 Revenue was \$15,533,473.00 with a net margin of \$1,811,579.00. Total assets are \$54.1 million. KWH sales usage for 2022 was 136,848,099 KWH.

2023 year to date Cooperative happenings:

- The Cooperative experienced a major ice fog storm in January.
- Continued growth of the Cooperative. "The Cooperative is busy".
- A new construction work plan/RUS loan was approved in May.

President Gessele introduced Troy Presser, MEC Director as well as the Cooperative's Director to Central Power and the Central Power Director to Basin Electric who provided a Generation and Transmission Report.

 During his report, Director Presser thanked the attendees for the honor to serve them.



ANNUAL MEETING MINUTES, CONTINUED

- 2022 was a great year for Basin. Basin cut its rate by \$1 million and retired \$22 million of capital credits.
- Basin Electric experienced multiple all-time peaks in 2022 with the highest peak in September.
- Basin Electric has plans to build two transmission lines to Canada.
- DGC was approved for a CO2 Storage Permit and Basin rejected its latest offer to sell DGC.
- He showed SPP maps of energy usage and expressed the need for more transmission in the Williston Basin.

General Manager/CEO Doyle provided a Operation Round-up report and explained how Operation Round-up works. He introduced the board members.

In 2022 Operation Round-up received \$14,590.78 and awarded grants of \$6,000.00 to Fundraising Friends of Makoti, Mercer Community Center, Garrison Area Food Pantry, Turtle Lake Chamber of Progress "Bike Fest", YMCA Triangle Y Camp.

He told the attendees that a maximum of \$11.80 can be given in any year.

President Gessele introduced Vice-President, Darcy Klain, who announced that the terms for directors in District 2 and District 7 were up for election. The incumbent directors for those districts, Clarence Behles for District 2, and Larry Gessele for District 7 were running unopposed. Vice President Klain asked for the casting of a unanimous ballot to re-elect the two directors. Such a motion was made and seconded and the directors were re-elected.

General Manager/CEO Doyle announced the following employee service awards:

Manager Doyle presented the following scholarships:

The McLean Electric Scholarship to Justin Volson of Surrey High School, son of Steve and Elaine Volson, of Surrey, North Dakota.
- The 2023 Youth Tour Essay Contest Winner is Hannah Myers, of Garrison High School of Garrison, North Dakota.

President Gessele asked for any old business. There was none.

President Gessele asked for any new business. There was none.

President Gessele announced that the 78th Annual Meeting grand prize of \$1,000.00 would be given to a meeting attendee who was present. The 2022 winner was Arnold Moll. Other door prizes were presented as well.

President Gessele announced that the 78th Annual Meeting grand prize of \$1,000.00 would be presented in two \$500.00 prizes to attendees who were present. The 2023 winners were Robyn Bauer, of Garrison, North Dakota, and Karen Hanson, of Turtle Lake, North Dakota. Other door prizes were presented as well.



OPERATION ROUND UP®

Operation Round Up is a voluntary program in which McLean Electric Cooperative (MEC) consumers round up their monthly electric bills to the nearest dollar. The money goes into a trust fund, with grants awarded by a seven-member volunteer board.

Operation Round Up funds support qualifying individuals, families, or organizations in need of financial assistance. It assists with personal or family emergencies and community-based education, health, charitable, scientific, or safety programs or projects. Recipients must live within McLean Electric's service area, but don't have to be MEC members.

A total of \$11,900 was awarded in 2023. Nine organizations received grants when MEC consumers "rounded up" through the program in 2023:

- Max Public School Backpack Program
- TL Trails Project Brush Mower
- Our Savior Lord Pantry
- Guardian & Protective Services
- Elks Camp Grassick
- First Congregational Church Garrison Food Pantry
- Andrea Andrews Medical Expenses
- House Fire
- Turtle Lake Chamber of Progress (Bike Fest)

The groundwork to establish Operation Round Up began in 2012. Since awarding its first grants in 2013, MEC members contributed \$155,134.52 to the program. Grants totaling \$133,882.00 have been granted to 88 recipients since the program's inception.

The most a McLean Electric account could contribute annually is \$11.88. For most MEC consumers, contributions average about \$6 annually when each month's bill is rounded up to the nearest dollar.

Operation Round Up board of directors shall be elected and voted on by McLean Electric's sevenmember board of directors. Operation Roundup



directors are President Mark Jennings, Washburn; Vice President Debbie Boe, Turtle Lake; Secretary-Treasurer Carla Landenberger, Underwood; Steven Haakenson, Parshall; Lena Volochenko, Butte; Darci Behles, Garrison; Shelly Schumacher, Garrison.

The Operation Round Up board focuses on the organization's goals and mission in its ranking process as it reviews applications. Serving on the Operation Round Up board of directors is a voluntary, non-paying position.

McLean Electric Cooperative employees or board of directors are not involved with the Operation Round Up board or its decision-making. The cooperative's role is advisory, and it helps administer the program and ensuring bylaws and IRS 501(c)(3) regulations are followed.

Recipients can apply more than one time and must be an Internal Revenue Service 501(c)(3) federal tax-exempt organization. Individuals with medical or emergency financial needs can receive grants through nonprofit organizations' grant requests. 




