McLean Electric Cooperative annual meeting minutes

June 20, 2023

The 78th annual meeting of the members of McLean Electric Cooperative Inc. was held at the company's headquarters in Garrison, N.D., on June 20, 2023. The meeting was called to order by President Larry Gessele at 6:30 p.m.

Dinner was prepared by Border States Electric and served by the Board of Directors and staff, and the Garrison American Legion Team, "The Titans."

Secretary Rod Stockdill informed President Gessele that a quorum was present and President Gessele informed the attendees that the Cooperative was open for business.

President Gessele introduced Pastor Rick Torkelson of Washburn Baptist Church, of Washburn, North Dakota, who gave the opening invocation.

President Gessele recognized present and past military service personnel and led the attendees in the Pledge of Allegiance followed by the playing of the National Anthem.

President Gessele introduced the dignitaries and guests who were in attendance and introduced Jessica Bell, Vice President of Government and Public Affairs of Rainbow Energy Center, to provide a keynote address. During her address, she reported that Rainbow is celebrating the first anniversary of taking ownership of the Coal Creek Station and the Nexus DC line. She spoke about the projects involving Coal Creek Station, the Nexus line, Discovery Wind Project, and carbon capture and sequestration.

President Gessele reported that the notice of the 78th Annual Meeting and the minutes of the 77th Annual Meeting were ready to be read for approval. It was moved that a reading of the notice and minutes be waived and that they be approved as presented. The motion was seconded and carried.

President Gessele provided his President's report, as follows:

- He thanked those that helped put together this year's Annual Meeting.
- The Cooperative is experiencing high growth and has been very busy with three crews working.
- Meter change over is ongoing.

- The cooperative is as financially sound as ever.
- He recognized the cooperative staff and thanked them for their work and service to the cooperative.

 President Gessele introduced General Manager/CEO Mark Doyle to provide his address to the attendees.

Manager Doyle discussed the following:

2022 year review:

- The closing of the Coal Creek Station sale to Rainbow Energy.
- Ice storm experienced with many outages and downed poles.
- No lost time by any of the crews.
- Improving member communication. The continuation of the supply chain issues.
- The Cooperative is involved in community support, including the provision of scholarships to local school districts in the cooperative's territory, Kids' programs and community donations and sponsorships totaling \$23,795.
- 2022 was a financially strong year for the Cooperative. The Cooperative experienced a 5.4% plant growth and ended 2022 with an equity ratio of 36.1%. 2022 revenue was \$15,533,473.00 with a net margin of \$1,811,579.00. Total assets are \$54.1 million. KWH sales usage for 2022 was 136,848,099 KWH.

2023 year to date Cooperative happenings:

- The Cooperative experienced a major ice fog storm in January.
- Continued growth of the Cooperative. "The Cooperative is busy."
- A new construction work plan/RUS loan was approved in May.

President Gessele introduced Troy Presser, MEC Director, as well as the Cooperative's Director to Central Power and the Central Power Director to Basin Electric who provided a Generation and Transmission Report.

- During his report, Director Presser thanked the attendees for the honor to serve them.
- 2022 was a great year for Basin. Basin cut its rate by \$1 million and retired \$22 million of capital credits.



- Basin Electric experienced multiple all-time peaks in 2022 with the highest peak in September.
- Basin Electric has plans to build two transmission lines to Canada.
- DGC was approved for a CO₂ Storage Permit and Basin rejected its latest offer to sell DGC.
- He showed SPP maps of energy usage and expressed the need for more transmission in the Williston Basin. General Manager/CEO Doyle provided an Operation Round Up report and explained how Operation Round Up works. He introduced the board members.

In 2022, Operation Round Up received \$14,590.78 and awarded grants of \$6,000 to Fundraising Friends of Makoti, Mercer Community Center, Garrison Area Food Pantry, Turtle Lake Chamber of Progress "Bike Fest" and YMCA Triangle Y Camp.

He told the attendees that a maximum of \$11.80 can be given in any year.

President Gessele introduced Vice President Darcy Klain, who announced that the terms for directors in District 2 and District 7 were up for election. The incumbent directors for those districts, Clarence Behles for District 2 and Larry Gessele for District 7, were running unopposed. Vice President Klain asked for the casting of a unanimous ballot to reelect the two directors. Such a motion was made and seconded and the directors were reelected.

General Manager/CEO Doyle announced the following

employee service awards:

- Travis Voth, Line Foreman 20 years
- Lucas Dusek, Lineman 15 years
- Lucas Schaaf, Engineering Manager 5 years
- Austin Dillard, Mapping & Computer Service Coordinator – 5 years

Manager Doyle presented the following scholarships: Basin Electric Scholarships of \$500 each to Coryssa Behles, of Garrison High School, daughter of Corey and Cynthia Behles of Garrison, and Cade Kjelstrup of Underwood High School, son of Christ and Taryn Kjelstrup, of Underwood. The McLean Electric Scholarship to Justin Volson of Surrey High School, son of Steve and Elaine Volson, of Surrey.

The 2023 Youth Tour Essay Contest Winner is Hannah Myers, of Garrison High School of Garrison.

President Gessele asked for any old business. There was none. President Gessele asked for any new business. There was none.

President Gessele thanked the attendees for attending the 78th Annual Meeting. The meeting upon a motion made, seconded and carried, was adjourned.

President Gessele announced that the 78th Annual Meeting grand prize of \$1,000 would be presented in two \$500 prizes to attendees who were present. The 2023 winners were Robyn Bauer, of Garrison, and Karen Hanson, of Turtle Lake. Other door prizes were presented as well





ALWAYS ASSUME ALL DOWNED LINES ARE

Downed power lines can be *deadly*. Always assume a downed power line is *live* and avoid approaching them or anything near them.

Use Precaution



Downed power lines can energize the ground up to 35 feet away. Even more in wet conditions.



Never drive over downed power lines or anything in contact with them.



If you see a downed power line, call 911.



Never try to move a downed power line.

If a vehicle contacts a power line or utility pole...

STAY AWAY AND CALL 911



Consider all lines to be live and dangerous.



Warn others to stay at least 35 feet away.



Stay in place or inside your vehicle unless you see fire or smoke.



Tell others not to approach vehicle, downed lines or anything that may be in contact with downed lines.



Call **911**.

In the Event of Fire or Smoke

Do not touch the ground and vehicle at the same time.



Jump from the vehicle with your feet together.



Shuffle away, avoid lifting your feet.
